New Federal and State COVID-19 Testing Requirements



In response to the final rule issued by the U.S. Centers for Medicare and Medicaid Services (CMS), published September 2, 2020, all Mayflower regular and contract employees are required to be tested for COVID-19 on a recurring basis. As a result, you may see activity in the Mayflower Estes House, 630 Park Street, where up to 150 employees will be tested in each phase.

If there is a positive case with a resident or employee, "outbreak" testing must be initiated. This means the frequency must be increased. Testing is based on local county COVID-19 activity. The ratio of positivity dictates the frequency of testing and is posted every two weeks on the U.S. Center of Disease Control and Prevention (CDC) website.

Here is the guide to Positivity Rates and resulting Testing Frequency: Low (less than 5%) = Once a Month for each employee Medium (5% - 10%) = Once a Week High (more than 10%) = Twice a week

Daily COVID-19 screening continues for residents and staff. This entails a daily register of individuals' temperature along with a health assessment. If an employee or resident is symptomatic, the individual will be tested. Mayflower will continue to follow existing policies and procedures for daily screening, use of PPE (personal protective equipment), contact tracing, and Phase regression.

Be an Early Bird! Don't Wait Until It's Too Late to Schedule Your Open Enrollment Counseling Appointment.

It can cost you money not to <u>review</u> your <u>Medicare Part D</u> drug plan coverage annually. In one hour or less, a volunteer SHIIP (Senior Health Insurance Information Program) counselor can complete a review, letting you know if you can save money and making sure you have access to the drugs you need. Last year SHIIP counselors helped Iowans save more than \$23 million. In 2019 fifty-

five Mayflower residents saved a total of more than \$19,000 by taking the time to do this. Are you one of them?

Even if you love your current plan, it's smart to look over the 2021 options because many plans change from year to year. See if you can beat your current plan on coverage, costs, or both.

Every year <u>between October 15th and December 7th</u>, you can enroll in or change your Medicare Part D or Medicare Advantage plan for 2021. Don't miss out on this opportunity. A SHIIP counselor can help you choose the lowest cost drug plan for 2021. Many things can change from year to year: whether your medications are on the drug plan's formulary, the tier level of your medications, your premium, whether your pharmacy continues to be a preferred pharmacy, and/or you're deductible. SHIIP can also help you check to see if you are eligible for extra help paying for your drug costs and your Medicare premiums and understand your options if you do not currently have a drug plan.

SHIIP is a free, confidential service of the State of Iowa insurance Division. Don't wait! 

Location: Enter through <u>Montgomery south door</u>; stop in the lounge to be screened by one of our nurses.

- Use hand sanitizer
- Get your temperature taken (if it's greater than 100.4, you will not receive your flu shot and will be asked to see your physician)
- Get screened for COVID-19

Travel through the hallway to the <u>MRA Conference Room</u> <u>in Pearson</u>, stay socially distant while wearing your mask. Socially distant seating will be available while you wait.

Upon entry of the MRA Conference Room you will:

- Use hand sanitizer
- Present your

- Receive your flu shot
