Celebrating Veterans Day at Mayflower

On Wednesday, November 11th, National Veterans Day, The Mayflower Community (Grinnell IA) celebrated its residents who are veterans and spouses of veterans. The original plan was to present a virtual address from veteran and resident Leo Lease to other residents in small group gatherings. Because of the escalating pandemic in the local area, those plans were abandoned. Instead, Leo's recorded address, to be shared later on Mayflower's Facebook, was presented individually to Health Center and Beebe Assisted Living residents and was emailed to independent living residents.

All 20 Mayflower veterans and 19 spouses were given thank-you cards crafted by Grinnell Middle School students, a special program listing all the Mayflower veterans, and mini-pies—apple or cherry—baked in the Mayflower kitchen. In addition, the veterans were given special walking sticks supplied by the American Legion.

For Health Center residents, "Veteran" and "Veteran Spouse" posters were hung at their doors, "Taps" was played at 11:11am by independent living resident Ed Adkins, patriot music was played on hallway speakers throughout the day, and each veteran and spouse were personally thanked by multiple staff members.

Killing Germs All the Way Around at Mayflower

Grinnell's Mayflower Community has acquired a second "Clorox 360®" machine to deal with the coronavirus.

This innovative electrostatic sprayer, with special nozzle, delivers Clorox disinfectants and sanitizers to the front, back, bottom, and sides of surfaces. This coverage provides better germ protection than is possible with human wiping

as it disinfects hard-to-reach surfaces.

Although sprayed spaces have to be vacated for 15 minutes, the work is usually performed early in the morning before residents and staff are active for the day. Within five seconds of spraying, 99%+ of bacteria is killed.

The **Clorox 360 is EPA**-approved to kill the coronavirus. In addition, the system manufacturer reports that it is EPA-approved to disinfect for 20 other organisms, including cold and flu viruses, MRSA, and Norovirus. On hard, nonporous, or soft surfaces, the spray action eliminates odors while stopping the growth of mold and mildew for up to seven days.

Before the onset of the pandemic, Mayflower acquired our

first Clorox 360 machine to fight flu germs. Since then, our focus has been the entire Mayflower campus—Health Center, Beebe Assisted Living, dining areas, and independent living meeting rooms and common areas. The second machine will allow us to hit these areas more often.

The machine is pictured in action.

None of this spray work precludes normal precautions—wearing face masks, social distancing, frequent hand-washing, regular cleaning of personal surfaces, and staying home when not feeling well. The battle continues!

One and Counting

Shirley is her name and she has a daughter named Sue. I want to briefly tell Shirley's story, because she is the only donor I have ever met who appeared to be motivated more by tax benefits than the charitable work she was supporting. "One and counting!" Shirley is the only tax-driven donor I have encountered over 34 years; I think you might enjoy hearing how our paths crossed nearly 30 years ago.

Shirley phoned the fundraising office of my employer, Hospital A. She said she was calling because no one answered the phone when she called the fundraising office of Hospital B. Shirley had never given a gift to Hospital A and had no other known connection. She wanted to donate real estate to create a life income gift, asking me, "Do you do those there?" Young and eager to please, I said "Yes we do, Shirley, please tell me more."

Shirley continued, "I am a 66 year old widow and my daughter, Sue, lives with me. I have a small farm on the edge of town which is now prime development land. I want to sell, but if I do, I'll pay huge capital gains taxes. I want a gift arrangement that pays me lifetime income, eliminates capital gains tax, and creates an income tax deduction. Can you help me?"

I visited Shirley's home to collect more information from her and Sue. Important side note: on that visit, I made the biggest relational faux pas of my career by incorrectly guessing (out loud of

course) Sue's age, 11 years higher than actual. That did not deter Shirley and we went on to complete the gift arrangement for Hospital A, giving Shirley the benefits she desired.

Maybe half a dozen years later, my phone rang again. I had moved to Charity C, and Hospital A had given Shirley my forwarding information. Same story: Shirley had other real estate, she wanted to do another life income gift, and she had no previous relationship with Charity C. I asked Shirley if I could tell her about the great work of Charity C and she said, "No, thanks, I just want to do another (gift)." Thankfully I made no relational mistakes, and the arrangements were completed even quicker than with Hospital A.

I do not expect to meet another like Shirley in my working lifetime. I write assuming you are passionate about the charitable work of Mayflower and other organizations as this year end approaches.

If you desire to support Mayflower or others this year, a quick gift planning visit may be helpful. The recent federal "Secure Act" and "Cares Act" made changes to important giving rules, creating a few opportunities that exist only until year end.

The same two pieces of legislation also created longer range opportunities. This is also a great time for exploratory conversation about your plans for next year and beyond.

Several great conversations with friends of Mayflower in recent days are motivation for telling my "Shirley" story and inviting you to explore your charitable passions. I look forward to hearing whatever is on your mind.

40,000-Piece Puzzle....COMPLETED!

John Noer, resident of Grinnell's Mayflower Community, has now finished the 40,000 piece Disney characters puzzle on which he has been working since February 1, 2019. As a result, John shaved the beard that he started growing when he started the puzzle. However, you can't see his smooth face unless he pulls down his mask...which we don't want at Mayflower!

The 22-foot long creation stands six feet tall and depicts 10 vivid Disney characters and scenes.

It is a product of Germany's Ravensburger Companies, founded in 1883 with the board game, "A Trip Around the

World," a take-off on Jules Verne's book, "Around the World in 80 Days." Today, the company not only produces games and puzzles, but also how-to and children's books and electronics. In 1998, they opened an amusement park in Germany.

The 10 Disney Scenes are Cinderella, Snow White, The Lion King, Dumbo, Beauty and the Beast, Bambi, The Jungle Book, Fantasia, Ariel the Little Mermaid, and finally, Peter Pan.

The accompanying photo shows John (with beard!) working on the last 150 pieces of *Peter Pan*. John reports that this last frame took him 145 days to complete, one of the longest

durations.

The final step with the puzzle is "editing." First, John has to match up all the connecting pieces, which for some reason, do not necessarily fit side-by-side. Then, with glue ordered from Ravensburger and on plywood purchased locally, John can lay out the puzzle for posterity. Jim Beckman of Grinnell's Beckman Gallery is planning to help John frame the puzzle. Jim framed John's last puzzle, a 9,000-piece beauty hanging in Mayflower's Carmen Center.

Where will the 22' x 6' masterpiece be hung? We are awaiting those arrangements. Stay tuned.

Summary of Enhanced Public Health Measures

Effective Tuesday, Nov. 17 at 12:01 a.m. until Thursday, Dec. 10 at 11:59 p.m.

Mask Use: Indoor spaces open to the public & State executive branch buildings

· Masks required when individuals are within 6 feet of one another for 15 minutes or longer with certain exceptions

Gathering Restrictions: Social, community, business, or leisure gatherings

- No more than 15 people indoors and 30 people outdoors
- These restrictions apply to wedding receptions, family gatherings, conventions, and other nonessential gatherings but do not apply to gatherings that occur during the ordinary course of business or government

<u>Sporting and Recreational Events:</u> Youth and adult group sporting and recreational gathering are prohibited except for high school, college, and professional sports

High School Sports & Extracurriculars: Sporting, recreational, and extracurricular events

- · Only two spectators permitted for each high school athlete, performer or competitor, and must wear a mask and maintain 6 feet distance from other spectators
- · Students can be closer than six feet and are not required to wear masks

Restaurants and Bars: Restaurant or bar, including a wedding reception venue, winery, brewery, distillery, country club, or other social or fraternal club

- Closed to in-person services at 10:00pm
- No bar seating
- · Masks required when not seated (while playing games, dancing, etc.)
- · Six feet distancing between groups
- · Groups limited to 8 people unless larger group is all same household
- Seated when eating or drinking and limit congregating

Fitness Centers: Fitness centers, health clubs, health spas, gyms

Group fitness activities are prohibited

Casinos & Gaming Facilities: Masks required except when seated to eat or drink

<u>Closer/Prolonged Contact Establishments:</u> Bowling alleys, pool halls, bingo halls, arcades, indoor playgrounds, children's play centers

- Closed to in-person services at 10:00pm
- · Mask required when not seated to eat or drink
- · Ensure that groups and individuals are six feet apart at establishment
- · Groups limited to eight people unless larger group is all same household

Nonessential/elective surgeries: A hospital must reduce its in-patient, nonessential surgeries to a level that uses at least 50% fewer beds than it did on average during September 2020



Re-Thinking Thanksgiving Plans

While we know many of you are looking forward to Thanksgiving gatherings, myself included, the **CDC recommends** staying at home this year. The safest place to gather is in your own home, with the people that live with you.

If you do choose to gather with your family or close friends, follow these guidelines as best as possible in order to mitigate your chances of coronavirus exposure or other flus:

- -Wear a mask.
- -When eating/not wearing a mask, maintain 6 feet of social distancing.
- -Wash your hands frequently.
- -Minimize touching of shared surfaces.
- -Bring your own plates, utensils, etc.
- -Avoid populated gathering areas, such as the food prep station.
- -After your gathering is over, quarantine for 3-5 days in order to monitor yourself in case you have any symptoms.

Another perk: Zoom (the video chat service) has announced they will be lifting the 40-minute time limit for their free subscribers during Thanksgiving so that families and friends may gather virtually, without time restrictions. During the holiday, you may virtually gather as long as you wish without worrying about Zoom's free services booting you out!




